***For the editorial board and auditors:**

* _ The care of preserving the rights of researchers and other authors before agreeing to publish a publication in the magazine and to print it is a duty of the editor-in-chief to respect it, makes no decision to accept or accept Refuse to refer only to members of the Editorial Board and its advisers and assistants.

* _ The search calendar must be subject to high confidentiality.

* _ Make sure that the editor and his assistants keep information about the authors of the research (especially those who play a role in decision making). * _ Referees are selected

* _ The arbitrator is required to verify the authenticity of the said references by specifying the authenticity of the author's references and those he has hidden from them and informing the editor of all the doubts about the credibility of the work with respect to similarity or overlap with other works on the same subject.

* _ Referees must maintain the confidentiality of the authors' information and research during the arbitration process.

* _ After accepting the article for publication, the editorial board is obligated to enable the author to obtain the following scientific documents: A certificate of acceptance of publishing the article either in the upcoming issues of the magazine, or a certificate of publishing the article, provided that a request is sent to the professional mail of the journal: revue_recherches_juridiques_economiques@cu-aflou.dz

* _ The accepted articles are published according to the specified calendar of each semester on the electronic portal of the Algerian scientific journals, to download the articles permanently and for free.

*** For Authors:**

* _ The editorial body has the obligation to guarantee equality and equality of opportunity for works submitted for publication.

- * _ The author must respect the formal and objective conditions of publication in the journal.
- * _ The author should move away from topics that generate sensitivities, be they political, ethnic, sexual or otherwise.
- * _ The author must adhere to the seriousness and originality of his work.
- * _ The author should not submit his work to more than one magazine.
- * _ The journal must be informed of the errors when it is informed of its presence once the article submitted for publication, either in the content of the information, in the organization of the presentation, or in the of its sources.
- * _ The author must make corrections and modifications to the article in case the resident asks for it.
- * _ Keep the private data used in his article and submit them at the request of the editorial board or references.
- * The journal is not responsible for the ideas included in the researchers' work, but remains under their responsibility.
